

# **Pioneer Flyfishing Limited**

## **Terms and Conditions of Booking**

1. Pioneer Flyfishing Limited hereinafter referred to as Pioneer.
2. The lead person must be at least 18 years old.
3. A deposit of £300 per person is required for all bookings (£200 per person for non-fishing clients).
4. All cheques to be made payable to "Pioneer Flyfishing Limited". We will send you confirmation of your booking/deposit upon receipt. Arrangements can be made for direct bank to bank transfer. Payment in Sterling (GBP) is preferred. We can also arrange payment in Polish Zloty or Euros.
5. Pioneer will only refund deposits if we, or our agents, are unable through our own fault to provide the services booked. Cancellation of flights is beyond our control and we cannot return deposits for this reason.
6. The final balance is due 8 weeks before departure.
7. Cancellations must be made in writing to Pioneer. The following cancellation charges will apply:

Up to 8 weeks before departure	Deposit only
More than 1 week, less than 8 weeks	60% of holiday price
1 week or less	100% of holiday price

8. The price is guaranteed not to change once a booking has been confirmed.
9. All persons must be fit to travel. Pioneer will not be responsible if people travel when not fit to do so.
10. All individuals must arrange and purchase their own travel and medical insurance. Pioneer are insured for public liability whilst fishing. We also have insurance for carrying guests in our vehicles and while in our accommodation.
11. Each guest will be given a comprehensive risk assessment for the river and fishing, and will be offered the use of an automatic life vest (provided). We strongly recommend use of the vest. The San is a large river, subject to rapid changes in flow rate because of release of water from the dams.
12. Pioneer declines any responsibility to accidents occurred if a guest walks or wades away so that he is no longer within sight of the guide when fishing. Staying in sight of the guide is crucial to safety.
13. When booking "All Inclusive" the following are included in the purchase price:
  - a. Transport to and from lodge/airport.\*
  - b. Transport to and from fishing daily.\*
  - c. Accommodation as specified.
  - d. All food (breakfast, lunch, dinner). Drinks with meals (*not alcoholic drinks*).
  - e. Fishing permits.
  - f. Fishing guide/s.
  - g. English speaking representatives.
  - h. The use of Hardy Greys tackle (we are endorsed by the Hardy Greys Academy)
  - i. Safety vests and wading staffs.

The following are not included:-

- a) Flights (Note that we can make organise the flights for you, by arrangement)
- b) Transport or accommodation in UK.
- c) Alcoholic drinks.
- d) Transport other than specified above.
- e) Food and drink other than that provided as above.
- f) Waders and wading boots (though these can be provided by prior arrangement)
- g) Single room occupancy will involve an extra charge

\* Arrangements can be made for guests to hire cars rather than use our vehicles and drivers. Pioneer declines any responsibility when client is driving a hire car.

14. Fishing a river is obviously dependant upon the prevailing conditions. If the river is un-fishable, other activities may be planned at the discretion of the local guides. Some activities may incur additional expenses, but will be optional.
15. Money cannot be refunded in the event of the river being un-fishable. The final decision of whether the river is fishable or not, will be decided by the local river guides.
16. All flies used must be tied on barbless or de-barbed single hooks. This is a rule on San River and Pioneer cannot accept responsibility if wardens find that guests are not observing this rule or others such as the banning of floating strike indicators. In most areas of the San a net must be used to land fish. Pioneer will supply nets to guests. All guests will be reminded about these and other rules of the fishery.
